## NCF Updates: Augusto reported:

- Interviews for a part-time programs manager position have commenced. Looking to have the position filled in time for the Maryland event
- Following up on sponsor leads.
- The Canon contact was not available so the former scholarship \$\$ may not be available. For Maryland.

## Public Relations Update: Waycott reported:

- California will attend 54 teams participating which include 2 teams from China.
- Still need more communication between Regional reps and the State/Prov rep.
- Suggest a FAQ on the website.
- Many questions have been fielded concerning registration accommodations.
- Team listing and pictures posted on the website
- Social media: continuing to post info on field events. More to come.
- Diversity Grant: Final reports starting to come in.

#### Maine Team member accessibility discussion:

The Maine team has a student who's confined to a wheelchair. Discussion on accommodations needed for the student to participate in the training, and testing portions of the event.

Can accommodate the student in the guest dorm.

An approved "note taker" will accompany the student. They will take notes on the training day but will not be able to attend the testing day.

Instruct the note taker not to interact with the team during the travel from the training day and during the study session.

Need to clarify to the note taker their parameters with the team.

Question on the request for a cell phone being carried by the student for emergency contact.

Wheelchair access will limited to the forestry station.

Maryland host members have been advised by legal council not to assist access during the training day.

The student an be transported to the forestry station early. The student's mother will be there to assist.

Additional time will be needed to move the student from site-to-site during training and testing.

Suggestion to contact with groups capable of assisting challenged individual with transport.

Burch stated that the forestry training site will be accessible to the student.

He requests NCF to render legal guidance.

Deusterhaus: Looking for Ops Comm recommendation to the NCF.

Need for documentation for future policy discussions.

Contact with Maine on the level of accommodation that can be achieved has been done. Further contact with Maine suggested on how the student was accommodated at the Maine field event.

More conversation with the student's caregiver may be needed.

Discussion on scheduling the movement of the student to the stations.

Options: -build in extra time to load and unload from the vehicle

-early arrival of the Maine team to the station that the student specializes in first.

NCF will follow up with the Maine team and caretaker
