Minutes: The minutes of the April 9th meeting were reviewed. Motion to accept as amended by Lowrance, second by Dryburgh: vote unanimous.

NACD Updates: Brooks

- Busy with numerous questions on the summer event.
- She has visited with various state committees, lots of travel.
- She presented at the international PLT conference on Ethon. Good connections were made.
- A draft of a newsletter will be released soon.

NACD Updates: Dremmel

- Sponsor/fundraising connected with 125 organizations with varying levels of awareness of the Ethon program. Potential sponsors include the Arbor Day Foundation, and EHS. She had a good interaction with the new Forest Service liaison, Iris Valez. She seeks to expand the FS agreement beyond the diversity grant program.
- She would like to meet with State and Provincial reps on increasing partnerships with local and national entities.
- Brooks will be visiting various State and Provincial events starting this year.
- She will attend the PLT international conference in Little Rock to widen outreach and visibility of the program.

Public Relations Updates: Waycott.

Membership Dues – 49 states/provinces paid. 53 States/Provinces plus 2 China = 55

Intent to Participate – Official 52 submitted. Waiting to hear back from Louisiana and New Hampshire believe Newfoundland will be coming to NC - 4,

State/Provincial Competitions: Ohio and Maryland left for the month of June.

Always a struggle to get a winning name/photo from the state/provincial representative. Check their social media and website some have not been updated for a couple of years. Perhaps due to change of staff at the state/provincial level??

Possible Grant option if we could find some extra money is perhaps offer grants to the state/provinces to update their Envirothon websites/social media etc. ?

2019 Diversity Grants - Checks were released early May.

2018 Final Diversity Grants are due end of June. Jennifer has been in contact with Sue Cummings replacement and moving the file along for the next season. After NC one of the items on the agenda is to revamp the Diversity Grant Application and Requirements. We will need to discuss this further at the OC summer meeting in July.

We are having discussion on revamping the application for the grants and the release of funds. i.e. 50% 1st payment, 40% Interim Report 10% Final Report.

Registration –Registration went **LIVE** March 15, 2019.

State coordinators received an email a few days prior to their event to help explain the registration process. And, remind them to submit their 2019 Statistics.
