Burch opened the meeting at 9:16am EST.

Roll Call by Folger

Minutes: The minutes of the June 27th meeting were reviewed Motion to accept by Lowrance, second by Dryburgh vote unanimous.

NCF Updates: Augusto reported:

- She attended the NACD summer meeting in Minnesota.
- She is working on funding opportunities, including former Ethon students.
- NCF looking at a possible raise in annual dues
- Discussion on cost recovery for team registration. Ontario costs are \$400 per person, Maryland costs are \$2300 per team. Concern on balancing costs with states/provinces ability to raise \$\$ for registration, travel. Concern on loosing teams due to increased fees.
- Discussion on dues deadline to be held firm
- Discussion on consistency between the host and NCF on what sponsors are provided.
- Augusto would like any potential funding opportunities forwarded to her.

Public Relations Update: Waycott reported:

- 51 teams, plus the Chinese team are registered.
- 59 guests are currently registered, half are staying on campus.
- Registration went well. 15-20% had some issues, but most were from not reading the info provided.
- Issuing of checks could be a challenge due to internal communication failures. More follow-up by local Reps is needed.
- Website local programs section has had about 40% of the teams contributing. Lots of time spent chasing people. Front page will be changed today for the competition.
- The Learning Management System (LMS) will be changed to make it more interactive.
- Statistics: 22 replies from states/provinces. Reminders will be given out at the reg. table to encourage more entries.
- Student/Advisor surveys were sent out to teams after registration, we have received about 100 responses.
- Smithfield food confirmed the cash awards. Met with them to access their needs as a sponsor. Some states had a challenge to get their local Smithfield companies involved.
- Smithfield comments on the lack of social media mention of their participation.
- Media outreach: More presence on facebook and twitter this year. Press releases went out to all states and provinces.

2016: Ontario – Kaknevicius and Keen reported:

- The final event program was reviewed.
- Keen reviewed the budget:
 - o Registration is below expected so the commitment to the college was short.
 - o Lack of name recognition of Ethon was a challenge for sponsors.
 - o Expectation of sponsors between NCF and host was worked out in the MOU.
 - o There is a perceived lack of NFC's role in supporting the program.
 - o \$\$ for food and accommodation is not popular with sponsors.
- Promotion of the North American program helped to expand the provincial Ontario program.
- Need for all players to understand their roles and responsibilities..
- A revised scoring rubric was handed out for review, it clarifies some items over the established one.

Motion to accept the revised rubric for use at the Event;

Discussion on point deduction for less than five team members. Current standard 2 point deduction on the oral score. Teams this year were told they could participate with no deduction

Motion to change the official name of the program to the "North American Envirothon while recognizing and maintaining the NCF's ownership and oversight of the program" by Hellstern, second by Lowrance.

Discussion on including "NCF" in the description of the program or the tag line.

Discussion on preparing a recommendation to the NCF on including the words "North American" Positives: marketable; funding; logo; instant recognition; growth; communications(social media); improve sustainability and continuity; brand equity.

How to include the NCF? Why do other countries "want in"?

Submit to the NCF in September. Look for a decision at the winter meeting in Denver.

- Education Committee Recruit science teachers. The National Science foundation continues to promote STEM. Possible partnership with the National Wildlife Foundation. Discussions on preparation of oral presentations by students before their arrival to the event.
- Diversity Grant Committee UFSF will contribute \$19K in 2016-2017 with an emphasis on reaching Hispanic students/schools.
