# **Old/New Business:**

- Competition guidelines will be updated and distributed for comment.
- There was a request to release the State/Province names that did not use the PowerPoint option. Discussion: Names released or not released: <u>Motion by Lowrance</u> <u>to not release the names of the State/Province that use the traditional method for orals.</u> <u>Second by Nordlund. Unanimous.</u>
- Nebraska made a request to release the problem scenario early (prior to the July event). Participants would then bring the finished presentation to the event on a flash drive. Reasons for the request:
  - Reduce the registration fee by saving a day
  - Less stress
  - Better presentations

- Concerns about originality of the presentations.
- Discussion on judge prep and questions to insure that the team knows the presentation material.
- Discussion on the merits and concerns
  - Fairness time of distribution of the scenario
  - Plagiarism
  - Time budget on members in July
  - Challenge of sequestration at the Event. Increases difficulty of the Event (sets it apart)
  - Outside help
  - Too polished, no content
  - Opportunity to return to sequestration in later years
