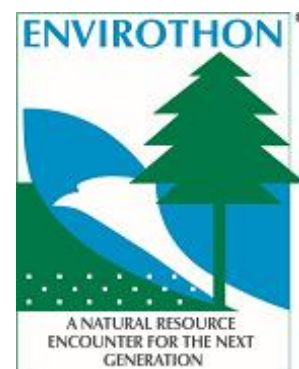

What to Expect while you visit Butler County, Ohio:

### Temperature

- Average daily high temperatures in July: 82-90°F/28-32C
- Average daily low temperatures in July: 61-68°F/16-20C
- Prepare for warm, pleasant temperatures!

### Precipitation

- Average rainfall in July: 4 inches/10.16 cm

### Insects to be aware of

- Ticks: Be prepared for the potential for ticks, especially while in and around tall grasses and shrubs. Take time at the end of every day to check for ticks.
- Mosquitoes: There is simply no avoiding them. Use a good quality bug spray and apply liberally.
- Other insects: Yellow Jackets, Hornets, Wasps, Carpenter Bees

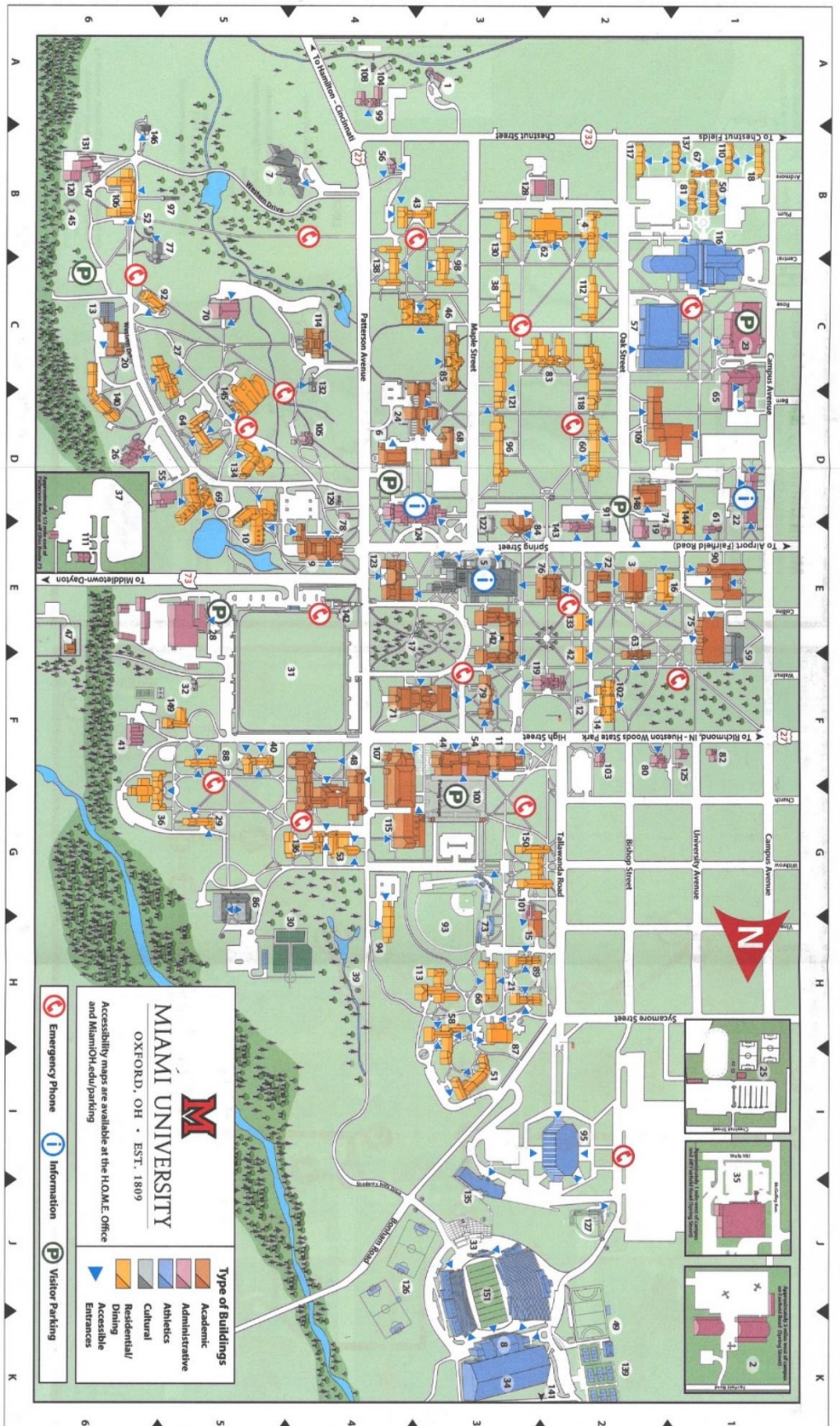

To register to attend the 2022 NCF-Envirothon Ohio Competition, please:

- 1. Complete the registration process outlined for each participation category**  
(Representatives, Advisors/Chaperones, Students and Guests) **by posted deadline!**

→ *Until all required forms are submitted for each individual registering to attend, the registration will be flagged as pending. Failure to submit by the deadline may result in ineligibility to attend.*

- 2. Complete payment for your registration selections by posted deadline!**

## Required Forms

### State, Provincial and Partner Nation Envirothon Program Representatives

All State, Provincial and Partner Nation Envirothon Program Representatives are responsible for completing the following two (2) REQUIRED Forms:

#### **I. Registration Invoice and Payment**

- REMINDER: The Team Registration Fee (\$1,800) is due by May 15, 2022<sup>1</sup>
  - Team registration fees paid after May 15 will incur an additional \$150 fee
- All other registration selections (1-day Team Early Arrival, Advisor/Chaperone Single Room and Guest/Advisor Tours and Workshop, etc.) can be paid at the same time as the Team Registration fee or separately before June 10, 2022<sup>2</sup>

## II. Team Certification

- a. Complete by June 10, 2022<sup>2</sup> to certify that the Team (including all team members, substitutes, and the team Advisors/Chaperone) meet eligibility requirements of NCF-Envirothon Competition Rules and Regulations

1. Team member names and information are not needed to meet the May 15 payment deadline. This payment can be submitted even if your state/provincial Envirothon competition is after this date to secure a spot for your TBD team to participate in the 2022 NCF-Envirothon Ohio competition.

2. Envirothon programs holding their competitions on or after June 5th have an additional 7 days from the conclusion of their event to complete the team registration/team certification forms.

### Dining Accommodations

Miami University's Food and Beverage team is committed to providing our patrons with an exceptional on-campus dining experience that takes into consideration student dietary needs, lifestyle choices, cultural backgrounds, and religious affiliations. We offer dining assistance to Miami University students, summer program participants, and visitors/guests. Our goal is to provide the same level of assistance for campus visitors and summer program participants as we do for our full-time students. We offer a variety of options for students and guests in each dining location. Our menus are designed to include those who avoid gluten and nuts, as well as those who follow a vegan and vegetarian diet. Below is what we provide every day on campus

### Allergen Icons

In each dining location we utilize allergen icons to indicate the major eight allergens as well as pork, poultry, beef, vegan, and vegetarian. These can be seen on our menu boards for each served item.



### Vegan and Vegetarian

We serve at least one vegan entree during each meal period at every Commons location in addition to our vegan desserts. You can identify these through the vegan icon on our menu boards. We also offer four vegan entrees available upon request at all of our commons dining locations. Additionally, vegetarian entrees and sides are available daily and indicated as such with our vegetarian icon.

### Dairy Allergy or Intolerance

We offer soy milk at each location as an alternative to cow's milk. We also offer other varieties of dairy free milk and products at our convenience markets.

### Gluten

Our menu items containing gluten are identified with our gluten icon. We offer gluten free bagels, bread, hamburger buns, hot dog buns, pizza crust, pasta, tortillas, muffins, and cookies. We also have a designated gluten-friendly station at Maplestreet Commons that offers gluten free pizzas, sandwiches, and entrees.

### Peanut and Tree Nuts

Miami University is a "nut friendly" campus. This means that we do not actively use nuts in our recipes. We also do not purchase commercial products that contain a "may contain [nuts]" statement. However, we do carry products that contain a "produced in the same facility as [nuts]" and/or "processed on shared equipment with [nuts]" statement. These items are coded on our menus with an allergen icon that resembles a factory. We do carry sealed nut products in our convenience stores and our "nut friendly" initiatives do not apply to any Starbucks location.

### Healthy Option

Miami University has added an additional icon to inform guests of healthy menu options.

## Special Dietary Needs

Guests with food allergies, food intolerances, or other special diets that require abstaining from certain food items (*i.e., medical conditions*) that exceed the offerings listed on the previous page, may fill out a [Self-Disclosure Dietary Needs Form](#). Once submitted, a Miami University Registered Dietitian will contact you for further discussion regarding your dining accommodation needs.

**Please ONLY submit a form if your dining need is such that the standard Miami University Dining Options (as described in the previous page) will not suffice!**

Envirothon students and/or guests should submit their self-disclosure dietary request form by **July 8th**. Please understand that there may be a considerable time commitment involved in working out the details of your dining accommodation needs.

Planning and communicating with Dining Services is essential and entirely up to the individual requesting services. NCF-Envirothon is NOT responsible for contacting the Miami University Registered Dietitian on your behalf and will not be involved in special dietary needs requested through their 'Self-disclosure Dietary Needs Form' portal. However, if you have a special dietary need, you are encouraged to include that information on the required 2022 NCF-Envirothon Ohio Competition: Medical & Insurance Information and Release form so that the Ohio Host committee will be aware for any meals eaten off campus during the competition week.

## Background Checks for Adults

Miami University requires all adult Guests, Team Advisors/Chaperones and Volunteers to have passed a Criminal Background Clearance (CBC). Information on the type of CBC needed can be found below. Information on the status of your CBC will be collected during registration process.

**Criminal Background Clearance (CBC)** - Miami University ask that all responsible adults having direct contact with minors undergo a criminal background check prior to engaging in a Program where they will be sharing facilities with minors (*i.e., showering, changing, or sleeping facilities*). Miami University recommends that background checks include a criminal background check conducted by the Ohio Bureau of Criminal Identification and Investigation (BCII), as well as an FBI records check (officially called an FBI Identity History Summary Check and requires fingerprint submission).

Depending on your registration status, Miami University asks the following from any adult attending the 2022 NCF-Envirothon Ohio competition:

### Team Advisors and Team Chaperones:

Team Advisors/Chaperones should have on record or shall complete before attending the 2022 NCF-Envirothon Ohio Competition, the same level of background check that your school or school system would require of any of its teachers/educators who will be sharing facilities with minors (*i.e., showering, changing, or sleeping facilities*). Same would apply for those attending from outside of the United States.

- If you are currently employed, and are in good standing, with a school or school system (public or private) and **HAVE** a background check on record with that institution, then that will suffice the requirements and you check 'Yes' on the Team Advisor/Chaperone Registration form.



- If you are **not** employed by a school or school system, but **HAVE**, within the last four (4) years, completed adult volunteer background check requirements of the school your team is affiliated with, then that will suffice the requirements and you check 'Yes' on the Team Advisor/Chaperone Registration form.
- If you are **not** employed by a school or school system and have **NOT** completed any background checks within the last four (4) years as a requirement of being an adult volunteer, then you will need to check 'No' on the Team Advisor/Chaperone Registration form **and** complete a CBC that is comparable to one required by your team's school or school system as described above.

### Adult Guests:

Adult Guest will not be sharing showering, changing or sleeping facilities with students, except for those chaperoning Minor Guests (see next section). As such Miami University has asked that adult Guests have completed a CBC within the last four (4) years. Same would apply for those attending from outside of the United States.

- If you do NOT have a current CBC on file, you are required, at your own expense, to complete a Criminal Background Clearance and then submit verification of completion BEFORE attending the 2022 NCF-Envirothon Ohio Competition. Your Guest Registration will be marked PENDING until verification is submitted.
- You may obtain a CBC through [SELECTION.COM](https://www.selection.com)® (\$35.00 USD plus cost of court fees for select US counties) or comparable service.

### Adult Guests who are also Chaperones of a Minor Guest (under the age of 18):

Chaperones of Minor Guests will be housed in the same suite as a minor. As such Miami University has asked that Chaperones of Minor Guests should have on record or complete same level of background check that your school or school system would require of any of its teachers/educators who will be sharing facilities with minors (i.e., showering, changing, or sleeping facilities). Same would apply for those attending from outside of the United States.

### Training Day (Monday, July 25)

On Training Day (July 25th), teams will attend Training Sessions covering the 5 Areas of Study (Stations).

There will be three (3) training Sessions in total. Each will be 90 minutes in length and each round of a particular subject will cover the exact same content.

Each team member will be assigned a Session group that will visit 3 Stations. At each Station, team members are encouraged to take notes (notebooks will be provided) and ask questions during the designated time. They will be able to share their notes with the whole team at the Team Study Session that evening.

Advisors are required to designate which training sessions each student on their team will attend during the registration process. Team members cannot repeat a station, and two team members should not be at the same station at the same time.

Students will have 90 minutes at each of the (3) Station Training sessions. Students will be encouraged to write down any questions they have during the Station Training session in the notebooks provided to them. During the last 15 minutes of each Station Training session, questions will be asked and answered as a collective group at the conclusion of the training session - this will ensure that all students present at that station will be able to hear the question and the response from the natural resources professional. All student notebooks will be collected before the students board the buses to return to campus. Notebooks will be made available for the team study session on Monday evening. Any notes taken from this training day can and are encouraged to be used during the Oral Presentation Prep.

### 2022 NCF-Envirothon Ohio - Training Day Sign-up Form

The 2022 NCF-Envirothon Ohio Host Committee has devised a training format that incorporates communication and team building skills. There will be (1) team member assigned to each training session that is offered. Therefore, there will be (1) student from the team at each station at one time. As a team, you should discuss and decide prior to the deadline of June 10, 2022, as to who will be attending which training sessions.

#### Things to consider:

- Each student will attend only 3 of the 5 training sessions offered throughout the day. They will not attend the same session twice.
- Advisors need to decide which training sessions each student will attend that will benefit the team.
- Students will have labels on their badges that will identify which sessions they will attend.
- There will be a Study Time, an optional time to collaborate with the Advisors, after dinner for the students to share the information learned. They will have access to their 'notebooks' at this time.

*\*If your team does not assign students to training sessions, the 2022 NCF-Envirothon Ohio Host Committee will assign your team members to each training session, and there WILL NOT be an option to change the training assignments.*

### Testing Day (Tuesday, July 26)

The testing format for the 2022 NCF-Envirothon Ohio will be station testing. This means that every testing stop will have questions associated with that core subject (Wildlife, Forestry, Aquatics, Soils and Current Issue). Each core topic may also have additional questions related to the Current Issue.

### Fun Day (Wednesday, July 27)

All students, advisors and registered guests will be going to Kings Island amusement park (approximately an hour from campus). We will be traveling by charter busses. Details of the park/attractions can be found on their website [here](#).

Your ticket will give you access to all the rides, waterpark, shows, and more. If you choose to enjoy the waterpark, please bring appropriate swimwear and a towel. Any games, locker rental, etc. will be on your own if you so choose. No outside food or drink can be brought into the park.

Kings Island is cashless and will only accept credit cards, debit cards, Apple Pay and Google Pay. The park will also have Cash-to-Card kiosks where people can transfer cash to a card with no added fees.



## Oral Presentations (Thursday-Friday)

Oral Presentations at the 2022 NCF-Envirothon Ohio will be 20 minutes in length. Students will be stopped at the 20-minute mark; the end of their presentation time. Judges will then have the opportunity to ask questions for up to 10 minutes following the presentation. The Top 3 Teams overall will re-present to the whole audience in front of a separate panel of VIP judges.

Advisors will not have any contact with their Teams from 8:00 am until all materials have been checked in. Advisors may greet their teams once the team has handed in their presentation materials at the end of the day.

Advisors may provide a basket or bag of snacks/goodies/drinks for the students during preparation time. **There will be NO refrigeration available for these snacks/drinks** – *please plan accordingly.*

Advisors can bring those items to the Ohio Host EOC before 11:30 am that morning. The Ohio Envirothon committee and volunteers will deliver it to your team that afternoon.

### Oral Presentation Judging (Friday, July 29)

In the morning of Friday, July 29, teams will present their OPs to a panel of 5 judges for a preliminary OP score. Presentation times will be assigned to teams during team registration on Sunday, July 24.

##### [Oxford Area Trails](#)

Over 30 years ago, an active group of residents came together and planned a network of trails to provide transportation and recreational opportunities to the residents of Oxford.

##### [Bull's Run Arboretum](#)

Bull's Run Arboretum features the last free-flowing section of Bull's Run Creek, which marked one of the original boundaries of the City of Middletown when it was plotted in 1802. The area was originally used as a grazing pasture for bulls in the mid-1800s.

The front of the Sanctuary serves as an arboretum, with labeled species of trees. Bull's Run holds a picnic area, mulched trails, and a creek side trail one-third of a mile long. The property serves as a wildlife laboratory for local schools, garden clubs, conservation groups, and nature enthusiasts.

### [Voice of America Metropark](#)

Voice of America Park is home to a variety of grassland bird species and other wildlife. The site also features miles of walking/jogging trails, premier athletic fields and a dog park.

### [Rentschler Forest Metropark](#)

With almost 400 acres, the Rentschler Forest Preserve and Miami-Erie Canal includes about a half-mile frontage along the Great Miami River, acres of woodland, remnants of the old Miami-Erie Canal, a prehistoric Indian earthwork, a reconstructed wetland, and ample opportunities for a wide variety of outdoor recreation activities.

### [Great Miami Riverway](#)

The Great Miami Riverway encompasses 99 miles of beautiful paved trails, river, and connections to several different communities in Southwest Ohio. This stretch of vibrant riverfront is full of boundless activity. Enjoy kayaking, canoeing, fishing, admire lush greenery & wildlife, ride your bike to free concerts & festivals, stop at great restaurants along the riverway, walk beneath a covered bridge and so much more.
